

Functioning as a platform for brotherly nations, the OTS has played a pivotal role in fostering diplomatic ties, facilitating cultural exchanges, and nurturing economic partnerships, thereby creating a cohesive and interconnected Turkic community. Together, we strive to navigate the complexities of the 21st century, pooling resources and expertise to tackle issues ranging from economic

development regional and technological security to advancements. fostering By unity and solidarity, the Turkic States are not only securing their collective interests also contributing to the broader global landscape, emphasizing the importance of cooperation in addressing the multifaceted challenges and opportunities of our rapidly evolving world.

Last years, we have witnessed a rising trend in the multi-faceted cooperation among the OTS Member and Observer States. We have taken significant strides on the basis of the Turkic World Vision – 2040 and the OTS Strategy for 2022-2026, while implementing crucial decisions made by our Heads of State.

The success of our Organization is highly associated with effective implementation of the initiatives of our leaders.

Since the establishment of the OTS, the number of cooperation fields of the organization has been increasing exponentially, particularly in the last year,

reaching 30 cooperation areas. At the same time, a due attention is being given not only to quantity, but also on the quality of implementation of the decisions taken within our organization.

Beyond a routine diplomatic gathering, this Summit was a powerful convergence of minds, solidifying shared values and sketching out a visionary blueprint for the future.

The Summit's resonance was not confined to the Turkic nations; it echoed globally, with international partners keenly observing the proceedings. The Heads of State showcased a profound understanding of the challenges and opportunities, laying the groundwork for impactful decisions.

At the heart of the Summit was the theme "TURKTIME"; a message from

the Turkic Leaders to future generations, symbolizing unity, cooperation, and a collective resolve to propel the Turkic World towards prosperity and development. Under the theme "TURKTIME – Traditions, Unification, Reforms, Knowledge, Trust, Investments, Mediation, and Energy" served as the guiding principles, encapsulating the essence of the Summit. As you know, much work has been done so far.

We have tangible achievements.

The Cooperation Council of Turkic-speaking States, established on the initiative of Kazakhstan, has become a full-fledged international organization.

The Turkic World Vision - 2040 has been adopted.

Most importantly, we have reinforced the unity of our brotherly countries.

We have shown the world our commitment to common values.

It reflects eight main priorities that will be spotlighted: Traditions, Unity, Reforms, Knowledge, Trust, Investment, Mediation and Energy.

We are fulfilling the will of our ancestors and enhancing cooperation among Turkic nations.

We must maintain our unity based on mutual trust and solidarity to pass it on to the next generation.

The Turkic world interacts with global powers on an equal footing.

Other nations are now reckoning with the key stances of our organization.

Therefore, extending relations between Turkic peoples is a common task for all of us.

Dear participants of the Summit!

The Turkic peoples inhabit a vast territory from Baikal to the Balkans.

It is well known that the civilization of the Turkic world originated in the Great Steppe.

The Organization of Turkic States is the successor of these common values.

Kazakhstan is interested in the further development of the Organisation of Turkic States.

Enhancing Turkic integration is a common goal.

We must promote the new Turkic World brand.

Only then the solidarity of the Turkic peoples will solidify and their potential increase.

Kazakhstan, as the Chair, gives high priority to invigorating interaction with the organisation.

We are also making efforts to establish collaboration in various fields, to enhance our international reputation.

To demonstrate Turkic unity, Kazakhstan's Chairmanship will have the motto TURKTIME!

It reflects eight main priorities that will be spotlighted: Traditions, Unity, Reforms, Knowledge, Trust, Investment, Mediation and Energy.

These priorities are short and medium term and span ten years to the 20th (twentieth) summit of the Organization.

Therefore, I suggest the following actions.

The first priority is Traditions.

In fact, the promotion of Turkic unity is paramount.

We are bound by shared history,

culture, language and mentality.

In this regard, it is necessary to uniform the flags and emblems of the Organization of Turkic States and its structures (following the example of the European Union).

Today, we will consider the presented sketch designs and make a joint decision.

It will be a historic moment.

It is our duty to explore the common archive and bring the historical truth to the descendants.

We propose to the relevant institutions to work together on unexplored sources.

This is truly very important work. There are gaps in our common history that need to be thoroughly researched.

It is also important to promote each other's TV series shot in our countries.

In particular, we should widely promote animated films for kids.

We think that social networks (YouTube, TikTok, Instagram) and popular media personalities can be involved for this purpose.

It will certainly create an opportunity for the spiritual rapprochement of the youth.

The second priority is Unification.

We have to ensure the coordinated development of the Turkic states.

We suggest systematizing the standards and terminology of the member states.

In this regard, I would like to encourage you all to draft a model law and approve it as soon as possible.

This initiative will allow free export of our goods to the common market.

Uniform standards will help to ensure annual GDP growth of about 1 (one) %.

Now the gross domestic product of our countries has reached \$1.4 (one and four) trillion.

This year, the turnover of goods between the OTS countries exceeded 22 billion US dollars.

This figure could increase by 1.5 (one and a half) times if we adopt common requirements.

In addition, I propose the establishment of the OTS Reference Centre.

This center will ensure mutual recognition of the results of product testing, as well as new research in the field of chemical and food industries.

The third priority is Reforms.

It is necessary to continue measures to streamline the organization's activities.

In this regard, I call for the swift appointment of our permanent representatives to the Organization of Turkic States.

We also welcome the idea of increasing the personnel of the Secretary General's Office

It is necessary to strengthen the cooperation of the Turkic states in the electoral field.

It is worth considering the establishment of an Advisory Council of Central Election Authorities.

International and regional structures have recently shown increasing interest in our organization.

We welcome the initiative to grant observer status to the Organization for Economic Cooperation and Development.

We also propose cooperation with the Islamic Food Security Organization.

The fourth is the importance of the enhanced cooperation in education and science through scientific cooperation (Knowledge).

In this regard, I propose to open branches of top universities in our countries.

It is necessary to hold joint scientific events and exchange experience.

We should organize efforts to open offices for language learning.

We have to pay special attention to the development of artificial intelligence, digital and aerospace industries.

The fifth initiative is Trust.

It's a turbulent time.

The international situation is also volatile. It is important to consolidate the unity of the Turkic peoples amid the challenging world situation.

It is imperative to ensure our collective security.

Arms and drug trafficking, terrorism, extremism, migration pose increasing dangers.

Stronger security cooperation is vital in countering these risks.

In this context, I propose to organise the third meeting of the Secretaries General of the Security Councils in Astana next year.

It is crucial to sign an agreement for a collaborative effort against crime and the exchange of information between the financial investigative bodies of the member states.

The sixth priority – Investments.

It is important to expand interregional trade and focus on investment in the economies.

The Turkic Investment Fund has a unique role in this endeavor.

To improve economic relations, it is necessary to establish a market for "green" finance.

As you are aware, Kazakhstan has proposed the creation of a Council of Turkic Green Finance.

Much work has been done to implement this proposal.

Today, the relevant document will be signed.

The proposal to grant Astana the status of the Financial Center of the Turkic world was supported by all parties.

I extend my genuine gratitude to all of you.

The seventh. The growing role of Mediation is a pressing matter.

Currently a difficult situation is unfolding around us.

In the north there is conflict between Russia and Ukraine, in the Middle East between Israel and Palestine.

The situation in Afghanistan is also volatile.

The problem of illegal migration is worsening in Western countries.

Today, civilians in the Gaza Strip, especially children and the elderly, are suffering from the conflict.

The most important task is to ensure their security.

Therefore, I have decided to provide \$1 million humanitarian aid to the Palestinian people.

It is simply inadmissible to use violence and acts of terrorism to address pressing issues that have persisted for decades.

Kazakhstan strongly condemns such actions.

The escalation of the conflict could lead to serious consequences.

In the meantime, we strongly advise to resolve any disputes through peaceful negotiations and dialogue.

Upholding the territorial integrity of all states and non-intervention in domestic affairs remain of utmost importance to us.

It is vital to strictly comply with the resolutions of the UN Security Council and to respect the norms of international law.

It is no secret that the Security Council is currently at a standstill.

Given this, the role of the General

Assembly should be strengthened.

At the same time, it is necessary to be more constructive in the reform of the Security Council.

In our view, this important body should include States from all regions of the world.

In particular, countries of the global South should not be excluded.

In light of the complex processes in the world, the Turkic countries should act wisely.

In this context, we should emphasise strengthening Turkic integration.

The eighth priority - Energy.

Saving energy resources is one of the most critical tasks.

Kazakhstanattaches great importance to the development of new energy sources, the modernisation and diversification of transportation routes.

We also have a keen interest in the introduction of best practices and technologies in geological exploration and power generation.

We pay special attention to the advancement of the petrochemical sector.

We value collaborative efforts in the field of "green energy".

I have proposed to host the International Energy Forum in Kazakhstan this year.

The event will allow us to copiously discuss all pertinent issues.

Climate change and sustainable

development are the foremost priority of Kazakhstan.

Kazakhstan took the initiative to host a regional climate change summit in 2026.

I believe that the fraternal Turkic states will support the above initiatives.

Dear friends!

It is very important for Turkic states to unite against threats, provide mutual support and act effectively.

Our ancestors said, "Even if our lives are different - the aspiration is one, even if all fingers are different - the hand is one."

Our shared success in strengthening Turkic integration is a prime example of this.

Following the Summit, a number of goals and tasks will be set and documents will be signed.

All this contributes to the prosperity of the Turkic world and the solidarity of our countries.


I also hope it will make a great contribution to the development of regional integration and raise the profile of the organization.

In particular, new structures such as the Organization of Trade Unions of the Turkic States, the Association of Notary Offices, the Academy of Space Research, the Geographical Council and the Drought Prevention Institute have been launched.

We have established close relations with several high-profile global and regional structures – the United Nations and its various subsidiary agencies, the Organization of Islamic Cooperation, the Council for Cooperation and Confidence-Building Measures in Asia and the

Economic Cooperation Organization.

Dear heads of delegations!

We are all witnessing today a deepening global crisis of confidence. New problems are emerging in the provision of global security, and cases of disregarding the norms of international law are increasing.

In particular, it is a matter of grave concern to all of us that the long-standing Israeli-Palestinian problem in the Middle East has become extremely dangerous.

The armed conflict has caused enormous civilian casualties, especially among elderly people, women and children, increasing the danger of conflict spillover.

We call on the parties to immediately stop military actions, ceasefire and for humanitarian purposes come to compromise.

The only and fair solution to this problem is to resolve the conflict on the basis of "two states for two peoples".

The Palestinian people have the right to an independent state as provided for in the United Nations resolutions.

We need to announce to the whole world our unanimous and determined position on this within our Organization.

Dear participants of the summit!

At our Summit, which is being held under the slogan "Turkic Era", I would like to make the following proposals for the further development of our multilateral and long-term relations.

First. Our main goal is to strengthen the principles of mutual respect, trust, and openness within the Organization in order to effectively overcome various obstacles together.

In this regard, I believe it is necessary to develop a "Charter of Turkic World" that expresses the unity of the Turkic peoples, their great past and rich culture and ancient values. I propose to draft this unique symbolic Charter with the participation of eminent scholars and experts in this field.

Second. The Turkic Investment Fund will be launched these days.

In order to strengthen industrial cooperation between our countries and implement large investment projects, we should also facilitate the establishment of the Turkic Development Bank in the next stage.

We are ready to host this financial institution in Tashkent.

Third. We fully support the practical work started on the establishment of the Turkic States Trade Cooperation Research Centre.

In the future, building on the capacities of the Centre, we need

to jointly implement the following specific measures:

- 1. removal of trade barriers,
- 2. widespread introduction of new mechanisms to increase exportimport volumes,
- 3. development of digital trading platforms.

Fourth. The development and diversification of global logistics chains and transport corridors, the formation of a unified transit network are of urgent importance.

We support the measures on increasing capacity of the Middle Corridor to meet the growing demand for freight transportation.

We also support the development of additional multi-network routes, including those corridors, passing through our countries to China, South Asia, and Europe and the digitalization of transport services.

We propose to set up the Council of Railway authorities of our countries. We are ready to host the Directorate of this structure in our country.

Fifth. We are interested in the development of a comprehensive cooperation in the field of ecology.

Since ancient times, our ancestors lived in harmony and coexistence with nature. Regrettably, today we are witnessing the increase in consumeristic approach to nature.

The entire humanity is suffering from various problems caused by climate change.

This situation requires urgent action from all of us.

Undoubtedly, the establishment of the TURKIC ECOLOGY FORUM at the ministerial level will represent a crucial step in this regard.

Such an influential mechanism is in line with our plans to enhance the effectiveness of our organization.

Sixth. The aspiration to elevate the Turkiccivilizationisdirectly associated with comprehensive support for technological advancements and progressive knowledge.

I am confident that our creative, talented, and energetic youth will pave the way for a new Renaissance of the Turkic World. The scientific discoveries and spiritual legacy left by our great ancestors will provide a solid foundation for their future accomplishments.

It is worth highlighting that memberstates are carrying out an extensive work to deeply study the exemplary activity and scientific and creative heritage left by our jadid ancestors who lived in the last century.

To propel these efforts to a new stage, we invite your representatives to take an active part in the International Forum "Jadids: National Identity, Independence and Ideas of Statehood" to be held in our country this December.

Along with this, in order to empower the enterprising and talented youth living in the pursuit of innovation, we believe it would be expedient to establish the Turkic World Creative Youth Centre in Uzbekistan.

In the past two years, I have paid 20 visits to the Member and Observer states of the Organization of the Turkic States. The leaders of the brotherly countries have on multiple occasions visited Azerbaijan within the same period of time.

The First Cultural Forum of the Turkic World was held in October in the city of Shusha. Availing myself of this opportunity I express my gratitude to you for the support extended for the declaration of Shusha as the Cultural Capital of the Turkic World for the year 2023.

Azerbaijan has invested more than 20 billion US dollars in the economy of Turkic states. The main part of the investments is being made to Türkiye.

The process of establishing the joint investment funds is underway The Azerbaijan-Uzbekistan Investment Fund and Azerbaijan-Kyrgyzstan Development Fund have been established.

From January to September of 2023,

Azerbaijan's trade turnover with the Turkic states increased by 40 percent compared to the same period of 2022.

Transportation and logistics occupy an important place in the development of our relations. Azerbaijan has proved to be a reliable transit country between the markets of the Central Asian countries, Türkiye and Europe.

Azerbaijan is making its valuable contribution to the sustainable operation of the East-West transportation corridor.

Dear colleagues,

Regrettably, today, the norms of international law are being flagrantly violated across different parts of the world. Wars and bloody conflicts are inflamed. Under such circumstances, primarily, the countries' defense capability becomes their main security guarantee. I believe that cooperation between the Member states in such spheres as security, defense and defense industry must be ramped up.

As you know, Armenia kept the territories of Azerbaijan under occupation for almost 30 years and created an illegal puppet regime there.

As a result of ethnic cleansing carried out by Armenia, over a million Azerbaijanis were expelled from their ancestral lands. Armenia razed our cities and villages to the ground, destroyed and desecrated our cultural and religious monuments.

All these years, Azerbaijan made efforts to resolve this conflict by peaceful means. However, Armenia was aiming at consolidating the status quo based on occupation.

Armenian Prime Minister's statement "Karabakh is Armenia, and full stop," made in the then-occupied city of Khankandi in 2019, put an end to the negotiations. The Armenian leadership was threatening Azerbaijan with a "new war for new territories".

Provocative actions and statements by the Armenian leadership in 2020, including military provocations, made the Second Karabakh War inevitable.

Azerbaijan using its inherent right to self-defense as enshrined in the article 51 of the UN Charter, defeated Armenia on the battlefield during the 44-day Patriotic War of 2020 and restored its territorial integrity and historical justice. We ourselves ensured the enforcement of the four UN Security Council resolutions demanding the withdrawal of Armenia's forces armed from Azerbaijan's occupied territories that had remained on paper for 27 years. The Second Karabakh War that lasted just 44 days ended with the signing of the capitulation act by Armenia on 10 November 2020.

Despite the policy of occupation and ethnic cleansing by Armenia against our country, it was Azerbaijan that declared its readiness to sign the peace treaty with Armenia and presented five basic principles.

Although in 2022 Armenia declared that it recognized Azerbaijan's sovereignty and territorial integrity, its real actions were totally illogical and controversial. The remnants of Armenia's armed forces were left stationed on Azerbaijan's sovereign territory. Armenian Prime Minister's congratulatory message on the socalled "independence" of the puppet regime on 2 September this year and the so-called "presidential elections" held on 9 September in Karabakh were a disrespect for and a direct threat to our country's territorial integrity and sovereignty.

An explosion of landmines deliberately planted by the Armenian illegal armed formations in the liberated territories on 19 September 2023 claimed the lives of six civilians and police personnel. In its aftermath, Azerbaijan launched local anti-terror measures to restore its constitutional order and neutralize illegal armed formations. As a result of the operation that ended in 23 hours, Azerbaijan fully restored its sovereignty and constitutional order. No damage was inflicted upon civilians and civilian infrastructure during the anti-terror measures. Azerbaijan fully complied with the international humanitarian

law. These facts were corroborated by the UN team that visited the region twice.

3 years ago, immediately after the end of the Patriotic War, Azerbaijan started large-scale restoration and reconstruction works across the liberated territories. 7 billion US dollars of Azerbaijan's budget funds have already been spent for these purposes. The allocation of at least 2.4 billion US dollars is envisaged for the following year.

Weare implementing the Great Return Program. The formerly displaced persons, the rightful owners of these lands, have returned to the cities of Lachin and Fuzuli and three villages. Over 140 thousand people are due to return to Karabakh and East Zangezur by the end of 2026.

I thank again President of Uzbekistan Shavkat Mirziyovev for the school, construction of which the completed in the city of Fuzuli. I remember with pleasure the school's opening ceremony in August. which we both have attended. I am grateful to President Kassym-Jomart Tokayev for the Creativity Center, Kazakhstan's gift to Azerbaijan which is under construction in the city of Fuzuli. All of that is a testimony to the friendship and brotherhood between the peoples of Azerbaijan and Uzbekistan and Azerbaijan and Kazakhstan.

The global developments of the recent period have been turbulent, and therefore I am pleased that we can now review this period from the perspective of the Turkic world. I would like to tell you that European politics dominated by serious challenges. We are facing dilemmas. difficult The answers that we will give in Europe will have an impact - a strong impact - on the relationship between Turkic world and Europe, so first of all I would like to talk briefly about this. In general, and in summary, from a European perspective global security is in the worst condition it has been in since

the end of the Cold War. Over the past thirty years the situation has never been as difficult and complicated as it is now. In Europe there has been a year and a half of war between Russia and Ukraine, there is armed conflict in the Middle East and a growing terrorist threat in the countries of the European Union, and at Europe's borders we are unable – with the sole exception of Hungary – to stop the surges of migration. Moreover, within a short space of time the world economy has been turned upside down twice – once by COVID and once by Ukraine. Energy prices have risen, and

this is seriously damaging European competitiveness. This is the situation in our region.

Honorable Presidents,

The core of the European dilemma is the question of what is in Europe's interest: either the formation of blocs in the world economy, or the development of global connectivity. This is the great debate that is taking place in Europe today. One tendency wants to push Europe in the direction of forming blocs. First European-Russian economic cooperation which is the basis of the European economy - was cut off; and now in Europe we are debating whether we should restrict the East, including the Chinese. The technical terms we use for this in Europe are "decoupling" and "derisking". The other tendency in this debate is the one to which we Hungarians belong. which strengthen cooperation seeks to in interdependence and sees opportunity for development and increased competitiveness. We would therefore like the coming period to be about connectivity and global interconnections. I know the Organization of Turkic States to be a champion of connectivity. I am convinced that the direction we have been following in recent years is the right direction.

I would also like to say a few words about the ongoing European debate on the Ukrainian-Russian war. This is a direct risk for all of us in

Europe, and Hungary is a neighbor of Ukraine. A year and a half has passed, and I have to say that so far it is clear that the European strategy has failed. The plan was that Ukraine would fight, we in the West would provide the money and the weapons, the result of this would be Ukraine's victory on the battlefield, Russia's defeat in the war, changes in Moscow, and our conclusion of an agreement with a new Russian leadership. This was a logical plan, an ambitious and logical plan, but it is not working. Therefore the guestion that now dominates European politics is this: should we face up to reality and come up with a Plan B? Some people propose continuing with what has been done so far, while others propose a Plan B. An item currently on the agenda is giving Ukraine 50 billion euros. This is a sign that the majority still thinks that we should continue the earlier, failed, strategy and finance it. Today this debate is causing great tension between European countries, and this will continue for at least two months. I can inform the presidents that Hungary is pushing for a Plan B, which aims for a ceasefire, peace negotiations and the construction of a new European security architecture that reassures Ukraine and is acceptable to Russia. I am convinced that such a new European security architecture must include Türkiye and – through Türkiye – the Turkic world; because without Türkiye it is impossible to imagine a sustainable

European security architecture that will bring long-term peace. I would like to take this opportunity to thank President Erdoğan for the efforts he has recently made to restore peace in Europe. We are counting on his contribution in the coming period!

Honorable Presidents,

In this international context, the role of the Organization of Turkic States is becoming increasingly important. The Turkic states have been able to exert a moderating influence on conflicts, and we have successfully intervened to reduce the risks of escalation. Hungary would like to continue to strengthen this policy within the Organization of Turkic States. I confirm Hungary's readiness to participate in the work of the Turkic Investment Fund, and we are maintaining our earlier commitment to contribute 100 million euros. Thank you for the opportunity to join the Turkic Green Finance Council. I would like to inform the presidents that we are one of the twenty countries in the world that is growing its GDP while reducing its emissions. We are honoured to be hosting the upcoming meeting of the Transport Connectivity Programme in Budapest. We will take advantage of the opportunities offered by the Turkic Special Economic Zone. We are negotiating the investment protection section of the Turkic Free Trade Agreement, which we would like to join as soon as possible.

I am confident that the current Summit will contribute to the further development of political-diplomatic, trade-economic, cultural-humanitarian ties between our countries and the identification of new tasks for the future in these areas.

Dear Summit participants!

Today, political contacts between member states of the Organization of Turkic States are of a high level. Our countries, supporting each other, effectively interact in bilateral and multilateral formats, as well as within the framework of the United

Nations and other international structures. In these difficult times, such close relationships are of special significance.

As it is known, in recent years the system of international relations has been going through a difficult period of its development. Complex political and strategic situations are taking place in different parts of the world, including in regions close to our countries.

As a result, the world community is faced with all sorts of global challenges and threats. To overcome these complex cataclysms that have a negative impact on the system of global peace and security, it is important for states to consolidate efforts, carefully assess the emerging political situations and make the necessary decisions.

In this context, relying on the norms of international law and, first of all, the Charter of the United Nations, it is necessary to create effective mechanisms to combat emerging threats, establish joint work, and develop specific approaches and plans.

In this regard, Turkmenistan, guided by the point of view of the indivisibility and integrity of security, at the 78th session of the UN General Assembly took the initiative to prepare a Strategy for Universal Security. For the practical implementation of this initiative, the Turkmen side considers it appropriate to apply the following three principles.

Firstly, to prevent conflict situations, in particular, at the initial stage of their occurrence, use preventive diplomacy;

Secondly, make full use of the capabilities of the neutrality mechanism;

Thirdly, restore a culture of dialogue based on trust.

We are confident that this Strategy will help strengthen mutual understanding and cooperation, resolve pressing issues facing the world community and implement the Sustainable Development Goals.

In this context, I am also firmly convinced that the Member States of the OTS will provide support in the practical implementation of this important initiative that Turkmenistan has launched.

As our respected brother H.E. Recep Tayyip Erdoğan has already said, the entire history of mankind confirms that there are no winners in war. An arrow fired will not come back; it does not choose victims, be it a child or a soldier. Therefore, neutral Turkmenistan is ready to support H.E. Recep Tayyip Erdoğan's initiative.

Speaking about international criteria for partnership, we put forward a proposal to adopt the Cooperation Program of the countries of the Organization of Turkic States for 2024–2025 for systematic interaction within the framework of international organizations.

With regard to the trade and economic

At the same time, first of all, it is necessary to indicate the directions that unite the economic sphere of our states. They include transport, energy, trade, industrial cooperation and other sectors.

In a word, we consider it necessary, in accordance with the requirements of the time, to fully and effectively use the economic capabilities of the Turkic states, acting in accordance with the main trends of world development.

Transport and logistics play an important role in relations between our states.

The above examples clearly confirm the relevance and effectiveness of the Trans-Caspian transport corridor being created with the participation of the Turkic states.

As you know, in the current climate of general instability, one of the key tasks is the creation of modern transport, transit and logistics systems connecting our states and widely ramified beyond their borders.

In this direction, Turkmenistan has come up with a number of large infrastructure projects in recent years that unite Asia and Europe. Countries that are members of the Organization of Turkic States also take an active part in them.

More precisely, in 2017, in accordance with the relevant Agreement signed in Ashgabat, the transport corridor Afghanistan-Turkmenistan-Azerbaijan-Georgia-Turkey was created. Currently, every effort is being

made to utilize this transport route to its full capacity.

Also in March 2019, at the initiative of Turkmenistan, the Caspian Sea – Black Sea transport corridor was created and a corresponding multilateral document was signed.

In addition, work is underway to form a transport corridor Kyrgyzstan-Uzbekistan-Turkmenistan with access to the Caspian Sea, which will then extend to Azerbaijan, and from there to Türkiye.

The above examples clearly confirm the relevance and effectiveness of the Trans-Caspian transport corridor being created with the participation of the Turkic states.

In this context, in order to enhance transportandtransitcommunications, I propose to use the potential of the logistics and infrastructure system of Turkmenistan.

Energy should be mentioned as another important area.

Possessing rich oil and gas fields, Turkmenistan pursues a policy of reliable and safe export of energy resources to the world market. In particular, Turkmen natural gas and electricity are supplied to neighbouring countries and states in the region.

In this direction, close cooperation has been established with the countries that are Members of the Organization of Turkic States.

As an example, Turkmenistan currently supplying its natural gas to

neighbouring and fraternal countries - Uzbekistan and Azerbaijan.

At the same time, there are opportunities to transport Turkmen natural gas through the Caspian Sea to Azerbaijan and Türkiye, and in the future bring it to world markets. I am confident that in the very near future, together with our fraternal countries, all necessary issues will be resolved and relevant work will be carried out.

Also, speaking of the electricity industry, Turkmenistan exports electricity to the fraternal countries - Uzbekistan and Kyrgyzstan.

In this area, in the future we will be able to supply electricity to Azerbaijan and Türkiye through the Caspian Sea.

Today on the Turkmen coast of the Caspian Sea near the city of Turkmenbashi, the foundation of a new modern power plant with a capacity of 1574 MGt was laid.

In general, we consider it advisable to prepare a roadmap for the development of cooperation in the energy sector among the Member States of the Organization of Turkic States to intensify and legally consolidate the ongoing joint activities.

I would like to note that cultural and humanitarian relations occupy an important place on the agenda of multilateral cooperation between Turkic states that have similar history, culture, language and traditions.

The close interaction established in this area is systematically developing

on the basis of friendship and brotherhood, mutual respect, trust and support for each other. As a result of strengthening partnerships in the fieldsofculture, art, science, education, and sports, favorable conditions are created for the rapprochement of our countries and peoples.

In this regard, I propose to regularly hold bilateral and multilateral cultural events, in particular, joint Days of Culture of the Turkic States.

At the same time, contacts are developing at a high level within the framework of the International Organization of Turkic Culture (TURKSOY). Noting the significant activities of TURKSOY in the cultural and humanitarian direction, I consider it appropriate to expand the joint events carried out within its framework.

Due to the fact that the 300th anniversary of the great Turkmen classical poet and thinker Magtymguly Pyragy is celebrated in 2024, as well as the proclamation of the ancient Turkmen city of Anau as the "Cultural Capital of the Turkic World", a number of international events are planned. In this context, we attach great importance to international cooperation, in particular, joint work with the Turkic people. I take this opportunity to invite you all to take part in the upcoming celebrations next year.

We also consider it advisable to strengthen cooperation in the fields of science and education, healthcare, sports and other areas. In particular, I propose to intensify contacts between research institutes, higher education institutions, and leading scientific centers.

I firmly believe that today's Summit, being a significant event, will give impetus to the further development of relations between the Turkic states.

Concluding my speech, I would like to wish you all great success in your activities, as well as well-being and prosperity to our fraternal peoples!

The above actions, besides having practical significance, contributed to the expansion of Turkic cooperation in general. In accordance with the Turkic World Vision - 2040, we have taken appropriate

In this context, within the framework of decisions taken at a high level on strengthening of the work of the Secretariat, an analysis of the implementation of the decisions made from 2015, when the OTS action plan has begun

to be adopted, to October 2023 was carried out.

As a result, it was determined that 54% of the instructions have been executed meaning that 214 out of 394 have been fulfilled. Analysis became an indicator of the increasing workload in the Secretariat, as well as the necessity of setting target oriented and feasible tasks based on the relevance and the interests of all parties. It also shows the need to coordinate the activities of the OTS and raise the effectiveness of the Secretariat's interaction with all the competent bodies of the OTS Member States and develop coordinated approaches between the Parties. At the same time, it showed the need to update the list of assigned tasks, by taking stock (inventory) of the instructions in fulfilling of which the parties did not express common interest or, due to objective circumstances, have lost their relevance.

Therefore, in order to strengthen the role of the OTS and implement large regional projects in the economic sphere in line with Your Excellencies instructions, the Secretariat has begun to take systematic steps to promote strategic initiatives. Emphasis is placed on projects such as "Middle Corridor", "China-Kyrgyzstan-Uzbekistan" railway, Turan SEZ, e-Permit, E-TIR, "Tabbaruk Ziyarot", "Sister Ports".

Additionally, to increase mutual trade in our region, there is necessity to sign a Free trade agreement in services and investment along with the Digital

Economy Partnership Agreement between the Member States.

Dear Heads of State and Government,

One of the key issues that need special attention is strengthening economic integration in the Turkic world. Currently, our mutual trade is 42 billion USD, representing only 5 percent of the total foreign trade turnover of our member countries. which is 850 billion dollars, this is far below our countries' potential. We need to increase this figure. Therefore, it is highly important to implement projects especially aimed at building a common market, creating favorable conditions for the free movement of goods, services and capital, as well as developing transport infrastructure and logistics centers to bring real benefits to our citizens.

In order to fulfill the tasks specified in the OTS Strategy - 2022-2026, we are successfully expanding cooperation with international organizations. Over the past year, we have done significant work with organizations headquartered in Geneva, Vienna, Brussels and New York and their regional offices.

Among them, I would like to highlight that we have signed a memorandum of understanding with UN-Habitat. We are currently in the process of developing a comprehensive road map for our collaboration with this organization, which will be finalized shortly. According to the established road map, our future endeavors will focus on the development of



socially and ecologically sustainable settlements particularly in Central Asia. Additionally, there are plans to establish a regional representative office of UN-Habitat in Istanbul in the near future. Furthermore, within the framework of the partnership between UN-Habitat and Azerbaijan, the National Urban Forum was successfully held in Azerbaijan at the end of September, and with the support of Türkiye World Cities Day was convened in Istanbul on October 31.

It is of utmost significance to highlight that last week, we inked an action plan with the World Health Organization (WHO). As an integral part of this plan, our focus will be placed on enhancing preparedness for emergency situations, augmenting the capacities of our healthcare system, and ensuring the well-being of our citizens.

Furthermore, we are developing road maps on collaboration with various organizations. These include

cooperation action plans with the Food and Agriculture Organization (FAO) on sustainable agriculture and rural development, the United Industrial Development **Nations** Organization (UNIDO) on matters concerning a unified market and standards, as well as endeavors to enhance trade relations with Organization for Economic the Cooperation and Development, and cooperative efforts with the International Renewable Energy Agency (IRENA) to jointly develop green energy sources. Mentioned documents for these collaborations will be signed in the near future.

Additionally, with an aim to promote our mission and values through public diplomacy we are working for convening in collaboration with the UN Office, Turkic cooperation organizations and our diplomatic representations in Geneva the "Turkic Week" in first quarter of 2024, in Geneva.

Your Excellencies,

The strategic location of the OTS region, disruptions in the European supply chain, and energy security concerns have significantly heightened European countries' interest in our Organization.

In this context, we should identify mid-term priorities of OTS Representation in Hungary and actively leverage its potential advance regional cooperation between the European institutions and the OTS. We emphasize the of intensifying importance activities of the Drought Prevention Institute in Budapest and the creation of a regional platform focused on drought and water resource management, climate change, and food security.

At the same time, Coordination Committee, which includes TURKSOY, Turkic Academy, Turkic Culture and Heritage (TCHF) Foundation and Parliamentary Assembly of Turkic States (TURKPA), is successfully being strengthened. The meeting of the Committee was held at the beginning of this year, in person for the first time, where a comprehensive review of their activities was carried out. This led to the adoption of an action plan comprising of 36 concrete points, ultimately paving the way for an enhanced contribution of Turkic organizations to our collaborative efforts and improved the system of coordination and implementation of decisions.

Esteemed Heads of State, Distinguished participants,

As I conclude my speech, I would like to emphasize that the organization of Turkic states is currently at a pivotal juncture. I firmly believe that the implementation of the decisions made by Your Excellencies, as well as the Chairmanship Concept of the President of the Republic of Kazakhstan, H.E. Kassym-Jomart Tokayev will usher in a genuine TURKTIME, fortify our unity, and elevate considerably our fraternal cooperation in the years ahead.

DECLARATION OF THE TENTH SUMMIT OF THE ORGANIZATION OF TURKIC STATES

Astana, Kazakhstan - 3 November 2023



The Council of Heads of State of the Organization of Turkic States met on 3 November 2023 in Astana, Kazakhstan on the theme of "TURKTIME". The meeting was presided over by H.E. Kassym-Jomart Tokayev, President of the Republic of Kazakhstan, and attended by H.E. Ilham Aliyev, President of the Republic of Azerbaijan, H.E. Sadyr Zhaparov, President of the Kyrgyz Republic, H.E. Recep Tayyip Erdoğan, President of the Republic of Türkiye, H.E. Shavkat Mirziyoyev, President of the Republic of Uzbekistan, H.E. Gurbanguly Berdimuhamedov, Chairman of the Halk Maslakhaty of the Milli Gengesh of Turkmenistan, H.E. Viktor Orbán, Prime Minister of Hungary, and H.E. Kubanychbek Omuraliev, Secretary General of the Organization of Turkic States.

The Heads of State of the Organization of Turkic States,

Underlining the successful completion of the Chairmanship of Uzbekistan in the OTS and highlighting the achievements of the Turkic world in 2023 – the Year of the rise of Turkic civilization;

Congratulating the jubilee Summit of the Organization of Turkic States (OTS) and reiterating their commitment to deepen and widen cooperation and solidarity in line with the purposes and principles of Nakhchivan Agreement on the establishment of the Cooperation Council of Turkic Speaking States, Turkic World Vision-2040, and the OTS Strategy 2022-2026 documents;

Underscoring their determination to carry forward the cooperation within the multilateral framework of the OTS based on common history, language, culture, traditions and values of the Turkic peoples;

Appreciating the remarkable political and socio-economic progress of the Turkic States and expressing satisfaction with the achievements made by the OTS since its establishment;

Emphasizing their commitment to enhance the organization's role in ensuring a deeper cooperation and coordination in the Turkic World and further promoting its values and interests in the regional and international arena;

Aiming at strengthening security and stability of the Member States in accordance with the international agreements which they are parties to, in particular those related to the respect of and support for the sovereignty, territorial integrity and inviolability of the internationally recognized borders, non-interference in internal affairs;

Underlining the importance of holding consultations on regional and international issues affecting the interests of the Turkic World in order to develop a consolidated position among the Member States;

Highlighting the utmost importance of continuing joint efforts by all Member and Observer States to enhance economic cooperation by promoting trade, transport, investment and regional connectivity initiatives.

Declared that they:

COOPERATION IN POLITICAL, FOREIGN POLICY and SECURITY ISSUES

- **l.** Adopted the Astana Act in honor of the Jubilee 10th Summit of the OTS convened under the motto of "TURKTIME", and underscore their unwavering commitment to boosting comprehensive cooperation and solidarity among the Turkic States within the framework of the OTS;
- **2.** Stress the importance of the Civil Protection Mechanism of the OTS and instruct the relevant bodies of the Member States and the Secretariat to finalize

the draft Agreement on the Establishment of the Civil Protection Mechanism of the OTS by the end of this year;

- **3.** Congratulate H.E. Shavkat Mirziyoyev, President of the Republic of Uzbekistan with the awarding of the Supreme Order of the Turkic World;
- **4.** Welcome the proclamation of February 6th as "The Day of Remembrance of Disaster Victims and Solidarity" upon the initiative of the Uzbekistan;
- 5. Congratulate wholeheartedly the 100th anniversary of the Republic of Türkiye with a deep sense of unity and shared purpose, looking forward to a future of continued collaboration, brotherhood; and having recognized the crucial role Türkiye has played in fostering strong ties and collaboration within the Turkic World, express their profound gratitude to the people and leadership of Türkiye for their steadfast commitment to the common values and aspirations that bind the Turkic nations together;
- **6.** Highly appreciate the successful organization of the "Qazqutkaru-2023" search and rescue competition, which took place at the training ground "Skalny Gorod Astana" in the Republic of Kazakhstan, and welcome the initiative of member states to organize joint exercises and competitions in the field of emergency response, with the aim of enhancing cooperation and exchanging experience among the rescue units of the Organization of Turkic States.
- 7. Welcome the outcomes of the Second Ministerial Meeting on Emergency Management held on 07 September 2023 in Baku, and conducting the disaster and emergency management training "Baku-2023 International Exercise", where the teams from the OTS countries jointly took part in the operations;
- **8.** Reaffirm their support to the normalization of relations between Azerbaijan and Armenia on the basis of mutual recognition of and respect for each other's sovereignty, territorial integrity and inviolability of internationally recognized borders;
- **9.** Appreciated positive role of the Consultative meetings of the heads of Central Asian states mechanism in the development, promotion and deepening the good neighborly relations among the states, settlement the security and stability in the region, strengthening brotherhood connections among the Central Asian people, and appreciate the participation of the President of the Republic of Azerbaijan as the Guest Honor at the meeting held on 14 September 2023 in Dushanbe, and welcome the next scheduled meeting in Kazakhstan, which will be held in 2024;
- **10.** Welcome the signing of the "Treaty between the Republic of Kazakhstan, the Kyrgyz Republic, the Republic of Tajikistan, Turkmenistan and the Republic of Uzbekistan on friendship, good-neighborliness, and cooperation for the development of Central Asia in the 21st century", which will provide stability,

security and interethnic harmony in the Central Asian region which are the main aspects of the sustainable development of the whole region;

- II. Welcome the full restoration of sovereignty of the Republic of Azerbaijan following local anti-terror measures of 19-20 September 2023, reaffirm their support to the reintegration efforts of the Government of the Republic of Azerbaijan, and while expressing appreciation for the support provided so far by Member States to the post-conflict rehabilitation and reconstruction works in Azerbaijan, reiterate their readiness to continue contributions to this end;
- **12.** Express satisfaction with the increasing involvement of the Observer States in the activities of the OTS and the Turkic Cooperation Organizations;
- **13.** Commend the decision of Hungary to second diplomats at the Secretariat of the OTS as part of its strong determination to boost cooperation and coordination with the Turkic World within the framework of the OTS, and reassure the resolve of the Member States to intensify multi-faceted cooperation with Hungary;
- **14.** Express condolences over the passing of Mr. János Hóvári, the late Executive Director of the Representation Office of the OTS in Hungary, who has made remarkable contribution to enhance comprehensive cooperation between Hungary and the Turkic States in his entire life;
- **15.** Continue and enhance their cooperation in fighting against all kinds and forms of terrorism, violent extremism, drug trafficking, illicit trafficking of cultural property, separatism, money laundering and the proceeds of crime as well as in combatting racism, discrimination, xenophobia, hatred against Islam, hate speech, and disinformation and to coordinate efforts in international fora in these fields;
- **16.** Commend the organization of the Second Policy Planning Consultations of the OTS on 18 May 2023 in Baku;
- **17.** Decide to expand cooperation on the fight against–irregular migration, including migrant smuggling and human trafficking, as well as on utilizing the development perspectives of legal migration taking the Sustainable Development Goals into consideration:
- **18.** Encourage to explore opportunities to hold regular migration consultations to deepen cooperation between the responsible migration bodies of the OTS member and observer states and to define the future vision in this field;
- **I9.** Express grave concern at the latest escalation of violence since October 7 and the grave deterioration of the situation in Gaza and the rest of the Palestinian Territory; condemn all attacks targeting civilians and call all Parties for an immediate ceasefire to protect civilians and their objects, as well as immediate, unhindered humanitarian assistance throughout the Gaza Strip; reiterate that a peaceful solution to the Israeli-Palestinian conflict can only be achieved by

peaceful means, based on the relevant United Nations resolutions, international law and two-State solution, and emphasize the need for a guarantee mechanism for its proper implementation;

- **23.** Welcome the holding of the informal meeting of the Council of Foreign Ministers (CFM) convened at the Turkish House on September 22, 2023 in New York upon the initiative of Kazakhstan and encourage the continuation of informal CFM meetings on the margins of the UN General Assembly on a regular basis;
- **24.** Express satisfaction by outcomes of the Conference of the Special Service Agencies of the Turkic States held on 28-29th September 2023 in Samarkand and welcome the decision to include this mechanism within the framework of the OTS:
- **25.** Welcome the initiative of the Kyrgyz side to organize joint meeting of the Heads of Ministries of Internal Affairs/Police of the Member States of the Organization of Turkic States in the second half of 2024 in the Kyrgyz Republic;
- **26.** Appreciate the successful organization of the 14th Meeting of the Council of Elders (CoE) on 18 October 2023 in Samarkand and support the continuation of the regular meetings of the Council of Elders as an advisory-consultative mechanism to underpin the efforts of the Secretariat to reach its targets;
- **27.** Commend the Astana International Forum with the motto of "Tackling challenges through dialogue: towards cooperation, development, and progress"

- on 8-9 June 2023 in Astana in order to unite efforts to address key global challenges, including those in the Turkic World in an age of growing polarization and geopolitical division;

- **44.** Commend the establishment of the Geographic Council of Turkic States (GCTS) on 9 May 2023, in Tashkent;
- **45.** Express the importance of further unifying efforts in order to strengthen cooperation in the fields of standardization, technical regulation, conformity assessment and accreditation among the relevant institutions of OTS Member States with the aim of eliminating technical barriers in trade without prejudice

to their international obligations;

among the OTS member states and observers;

Recognize the importance of the creative economy as one of the most important components of the development of the innovative potential of the Member States, call on the Member States to support the creative industry in order to help increase the competitiveness of economies, the development of small and medium-sized businesses and the expansion of the employment market of the Member States, including in remote and rural areas;
- **54.** Commend the efforts of the OTS Secretariat in exploring the opportunities of establishing potential cooperation areas (programs and projects) with WTO, UNCTAD, OECD, UNIDO and UNECE for benefiting from their experience and best practices, thus achieving a common agenda and policy among the Member States on trade facilitation, investment promotion, SME support and industrial development;
- Take note of the proposal of the Ministry of Industry and Technology of Republic of Türkiye in organizing first ever Ministerial meeting on Science, Technology, Innovation and Industry; calls for the Ministerial meeting to be convened at the earliest opportunity with the objective of strengthening cooperation in the fields of science, innovation, industry among member and observer states;
- **56.** Instruct the relevant institutions of the Member States to continue efforts to facilitate the transport operations across the Trans-Caspian International East-West Middle Corridor and to bolster transport cooperation among the Member and Observer States with a focus on the advancement of physical and digital transport infrastructure projects;

- **66.** Instruct the relevant institutions of the Member States to continue joint efforts aimed at simplifying customs procedures, introducing digital tools in customs operations, sharing best practices, conducting capacity-building programs, and ensuring the uninterrupted operation of customs-border checkpoints to enhance the competitiveness and attractiveness of the Middle Corridor;
- **67.** Commend the mutual expansion of low-cost flight operations between the Member States and task the national civil aviation authorities to continue their endeavors to further broaden the current air transport, air cargo and low-cost flight networks among the Member States;

- **68.** Welcome the holding of the Meeting of the Ministers in charge of Information and Communication Technology (ICT) of the Organization of Turkic States (OTS) on 20 June 2023 and support the outcomes of this meeting; in this regard, underline the importance of the 5th Meeting of Ministers in charge of ICT and field visit program on e-government to be organized in Bishkek;
- **69.** Praise Astana Hub for conducting the two "Hero Training programs" and 4th batch of a Joint Program "Silkway Accelerator" for technology startups from OTS Member States in Silicon Valley, USA in 2023;
- **70.** Commend the OTS Secretariat for organized field visit program for OTS Member States to "Technoparks and Innovation Centers of Türkiye" in close partnership with "Bilkent Cyberpark" on 9-11 May 2023 in Ankara and Istanbul, to exchange best practices and experiences of Türkiye;
- **71.** Appreciate the organization of a trade delegation by Bilkent Cyberpark to the cities of Almaty and Astana on 24-29 April 2023 as well as a trade delegation by companies located in Kazakhstan, which was held on 18-21 September 2023 in Ankara;
- **72.** Encourage the establishment of innovation and technology parks in Member States to foster research, development, and entrepreneurship in hightech sectors like artificial intelligence, renewable energy, and space exploration;

- **80.** Take note of the proposal of the Turkish side for the establishment of the Turkic World Human Resources Development Institute in order to follow the developments in the field of Human Resources and implement them more effectively;

- **II3.** Welcome the official announcement of the city of Istanbul as the "Youth Capital of the Turkic World-2023", and commend the organization of the 2^{nd} Young Entrepreneurs Forum and 5^{th} Young Leaders Forum of the OTS on 4 May 2023 in Istanbul;
- **II4.** Welcome the outcomes of the 7th Meeting of the Ministers in charge of Education of the OTS held on 14 June 2023 in Samarkand, Uzbekistan;
- II5. Taking into account the necessity of providing favorable conditions for the education of the young generation at the OTS, support the steps taken by the Secretariat for strengthening TURKUNIB and Orkhun Exchange Program, as well as implementation of the student-teacher exchange in the framework of Sister Schools Partnership Program within the OTS fostering a greater sense of unity and shared knowledge among Turkic peoples;
- **II6.** Welcome the holding of international conferences, forums, and workshops for the benefit of promoting and supporting the great cultural heritage of the Turkic peoples, including the Turkic Kagan Alp Er Tonga and others, which are an integral part of the Turkic statehood and history;
- 117. Appreciate the organization of the international conference on the theme of "Educational activities of the Jadids: ideas, goals, objectives and their contribution to the development of Turkestan" on 6-7 March, 2023 in Tashkent; and welcome the International Scientific Conference on the theme of Jadids: Ideas of National Identity, Independence, and Statehood" to be organized in Tashkent;
- **118.** Appreciate the organization of the VII World Epics Festival on 17-21 May 2023 in Osh, Kyrgyz Republic and call on the Member States to further promote intangible cultural heritage of Turkic people;
- II9. Take note of the initiative of the Turkish side on the establishment of the affiliated intergovernmental institution responsible for the sports agenda under the umbrella of the Organization of Turkic States with its headquarters in the Kyrgyz Republic; and instruct the Secretariat to take necessary measures to this end;
- **120.** Welcome the declaration of Shusha of the Republic of Azerbaijan as the "Cultural Capital of the Turkic World 2023" upon the initiative of TURKSOY,

express satisfaction with the activities organized in the city, also welcome the adoption of Anau (Anev), Turkmenistan as the "Cultural Capital of the Turkic World 2024", and of Aktau, Republic of Kazakhstan as the "Cultural Capital of the Turkic World 2025" and express their support to the activities that will be organized in Anau (Anev) in 2024 and in Aktau in 2025;

- **121.** Welcome the establishment of the Turkic World Common Alphabet Commission as an initiative by the Council of Elders of the OTS, support the outcomes of its first meeting held by the Turkic Academy in Astana on 29 May 2023, and urge the relevant authorities of the Member and Observer States to continue necessary work.
- **122.** Welcome the Final Declaration of the International Conference on "Integration role of the common Turkic Alphabet: Scientific and social aspects" organized by the Turkic Academy, Atatürk Supreme Council for Culture, Language and History, Turkish Language Association and hosted by Al-Farabi Kazakh National University on 27 October 2023 in Almaty;
- **123.** Appreciate the successful organization of the "International Türkiye Alumni Reunion" in Azerbaijan on 29-30 September 2023, held by Presidency for Turks Abroad and Related Communities of the Republic of Türkiye, and encourage the promotion of the further multi-national alumni collaboration among the Turkic States and communities;
- **124.** Commend the Türkiye Scholarships Programme's human oriented efforts to spread Turkic State's values, cultures and languages which is provided by Presidency for Turks Abroad and Related Communities of the Republic of Türkiye and its positive impacts on establishing a comprehensive bond between the countries of Turkic States and communities living across the world; and support the positive role of the Presidency for Turks Abroad and Related Communities of the Republic of Türkiye by virtue of contribution for strengthening the communication between sister diasporas in various countries;
- **125.** Recognize the importance of the 1st Turkic Statehood History Congress dedicated to the 100th anniversary of the Republic of Türkiye, organized by the Turkic Academy on 14-16 September 2023 in Cholpon-Ata, the Kyrgyz Republic, which promotes awareness and appreciation of common Turkic history;
- **126.** Encourage the Turkic Cooperation Organizations to develop activities for strengthening the skills of talented and educated youth, and appreciate the First Young Turkologists Summer School of the Turkic World organized by the Turkic Academy in June 2023 in Bishkek, the Kyrgyz Republic, dedicated to the Turkic states' history, archeology, language, and literature;
- 127. Acknowledge the conduct of archaeological works by the Turkic Academy

aimed at identifying ancient artifacts of Turkic history, including the continuation of excavations in the Arkhangal region of Mongolia (Nomgon-2) and the ancient city of Jankent in the Kyzylorda region of the Republic of Kazakhstan;

- **128.** Commend the successful organization of the International Language Forum of Turkic Peoples on 21 September 2023 in Bishkek with the participation of the academicians from Turkic states and heads of Turkic cooperation organizations;
- **129.** Acknowledge TCHF's efforts to promote Ancient Turkic writing worldwide, as exemplified by the international exhibition "Petroglyphs, Tribal Tamgas, and Ancient Turkic Writing" held in Amsterdam on 14-15 September 2023 and in Bern on 26-27 October 2023, and praise TCHF's endeavors to promote Turkic literature globally, including the publication of books dedicated to notable figures of the Turkic World,
- **130.** Commend TCHF for their restoration efforts, including the project to renovate the Alykul Osmonov house-museum in Bishkek and the upcoming "Architecture Conference" in Shusha and; recognize TCHF's contributions to the celebration of "Shusha the Cultural Capital of the Turkic World" through "Shusha Days" in Bursa in 2022, and in Tashkent, Budapest, Astana, and Turkistan in 2023;
- Appreciate TCHF's contribution to marking the jubilees of the Turkic World commemorating the 100th anniversary of Heydar Aliyev, the Great Leader of the Azerbaijani people, including a special conference in Astana jointly organized with the Turkic Academy, concerts of the "Seven Beauties" in Budapest, Bern, and The Hague. Congratulate TCHF on their initiatives to honor the 100th anniversary of the Republic of Türkiye, such as the "Cultural Heritage of the 19th Century Turkic World Through Yıldız Palace Photography Collection Exhibition" in Istanbul. Acknowledge the successful premiere of the play "Mother Field" in Baku on 26 April in honor of Chingiz Aitmatov's 95th anniversary;

INSTITUTIONAL COOPERATION IN THE TURKIC WORLD

- **132.** Support the further institutionalization of the OTS including the increasing of staff and budget of the Secretariat, in accordance with the compulsory contributions of the Member States to meet the objectives of the OTS, and instruct the Secretariat to carry out studies and prepare a report with concrete proposals until the next meeting of the CHS;
- **I33.** Acknowledging the Secretariat's dedicated efforts on the implementation of decisions taken by the Parties which will serve to review progress, evaluate the implementation of collaborative priorities;
- **134.** Praise the activities of TURKPA, TURKSOY, Turkic Academy and Turkic Culture and Heritage Foundation (TCHF), and take note of their reports

submitted to the Council of Foreign Ministers;

- 135. Encourage enhancement of cooperation among the Turkic Cooperation Organizations under the umbrella of the Secretariat of the OTS for the efficient implementation of the common Turkic cooperation agenda, and instruct the Chairman of the Coordination Committee to continue the practice of developing an annual Action Plan of the Turkic Cooperation Organization for 2024 to properly coordinate the activities of this structure;
- **136.** Appreciate the celebration of the 30th anniversary of the TURKSOY in the Member States, and wish success in promoting and popularizing the great culture of the Turkic peoples;
- **137.** Welcome obtaining of Observer Status by TRNC, as an integral part of the Turkic World, at TURKPA; and the Union of Turkic Chambers of Commerce and Industry (TCCI);
- **138.** Take note of the outcomes of the 12th Plenary Session of TURKPA held on 29 April 2023 in Ankara, and encourage its activities on the elaboration of model legislation;
- **139.** Commend the OTS and TURKPA on observation of elections and referenda in the Member and Observer States to support the political participation and good governance;
- **140.** Support the initiative of the Union of National Academies of Sciences of the Turkic World regarding broadening the scope of the working agenda of the Turkic Academy to include the natural and applied sciences, which are essential to maintaining the Turkic states' competitiveness in science and technology, and note with appreciation launching of twenty projects by Turkic Academy in the domain of history, languages, Turkic culture, and society;

COOPERATION WITH EXTERNAL PARTIES

- **141.** Urge strengthening the active cooperation of the Member and Observer States at international arena, and encourage supporting each other's candidacies and initiatives, as well as their resolutions and statements to be delivered on topics of common interest within international organizations, where possible;
- **142.** Welcome the Observer Status of the Economic Cooperation Organization (ECO) at the OTS;
- **143.** Express satisfaction with the rising attention of the third countries and international organizations in developing institutional cooperation with the OTS on areas of mutual interest, and urge to accelerate joint efforts to obtain

Observer Status for the OTS at the United Nations (UN) General Assembly and Organization of Islamic Cooperation (OIC);

- **144.** Welcome the initiative proposed by the Secretary-General to organize the "Turkic Week" event in Geneva, in close cooperation with the UN Office in Geneva as an initiative representing a significant opportunity to enhance the visibility of Turkic cooperation on the global stage, and instruct the Member and Observer States as well all Turkic Cooperation Organizations to work closely and collaboratively with the OTS Secretariat to ensure the successful organization of the "Turkic Week" in Geneva;
- **145.** Welcome the Memorandum of Understanding (MoU) signed between the Organization of Turkic States (OTS) and UN-Habitat, the United Nations agency responsible for sustainable urban development on 27 February 2023 at the OTS Secretariat in Istanbul;
- **146.** Commend the outcomes of the Meeting of Ministers in charge of Urban Planning of the OTS convened on 30 September 2023 in Baku, on the sidelines of the 2nd session of the Azerbaijan National Urban Forum and the World Habitat Day 2023;
- 147. Welcome the efforts of the OTS Secretariat on establishing close collaboration between the OTS and the United Nations Industrial Development Organization (UNIDO) in the realization of common objectives to achieve mutually beneficial development in the field of inclusive and sustainable industrial development in the OTS region, in particular clean/green energy, agro-industry, investments, digital industrial technologies, knowledge and experience sharing;
- **148.** Encourage the Secretariat to increase cooperation with all relevant international and regional organizations and carry out joint projects on areas of mutual interests;
- **149.** Task the Secretariat to carry out necessary works on the establishment of OTS Gulf Cooperation Council, OTS African Union and OTS European Union platforms and organize joint meetings;
- **150.** Welcome the adoption of the Road Map for Transformation of the Conference on Interaction and Confidence Building Measures in Asia (CICA) into a full-fledged international organization during an Informal Meeting of the CICA Council of Foreign Ministers on 21 September 2023 in New York;
- **151.** Commend the role of the Member States in extending development and humanitarian assistance to the third countries across the world that contributes to the attainment of the 2030 Agenda for Sustainable Development, and support further enhancement of cooperation among the development agencies of the Member States;

152. Take note of the importance of the adopted resolution of the United Nations 77th General Assembly's session "Sustainable Mountain Development", agreed to join efforts to implement the "Five Year of Action for the Development of Mountainous Regions 2023-2027";

- **153.** Congratulate the Republic of Uzbekistan for the successful Chairpersonship of the OTS in 2022-2023 under the motto of "New Era for Turkic Civilization: Towards Common Development and Prosperity", and highly value its great contribution to the activities of the Organization;
- **154.** Commend the significant achievements in the activities of the Secretariat of the OTS since the last regular Summit as presented by the Secretary General Kubanychbek Omuraliev in his report, and underline the necessity to strengthen the capacity of the Secretariat for effective implementation of its growing tasks;
- **155.** Commend the outgoing the Deputy Secretary General of the OTS Mr. Yerzhan Mukash and the President of the Turkic Culture and Heritage Foundation (TCHF) Ms. Günay Afandiyeva for their contribution;
- **156.** Decide to hold the 11th Summit of the OTS in 2024 in the Kyrgyz Republic. The Heads of States express profound thanks to H.E. Kassym-Jomart Tokayev, President of the Republic of Kazakhstan, for steering the deliberations of the Jubilee 10th Summit of the OTS to a successful conclusion and appreciate the warm hospitality of the Government and people of Kazakhstan. They welcome the assumption of the Chairmanship of the OTS by the Republic of Kazakhstan until the next Summit.

ASTANA ACT

WE, THE HEADS OF STATE
OF THE ORGANIZATION OF TURKIC STATES (OTS),



- **I.** Having met for the OTS Jubilee 10th Summit under the motto "TURKTIME! Traditions, Unification, Reforms, Knowledge, Trust, Investments, Mediation and Energy!" in Astana;
- **2.** Praising the life, works and legacy of our great personalities along that Silk Way, inter alia, representatives of the Turkic-Islamic Golden Age, who inspired us by contributing greatly to the creation and progress of the unique Turkic civilizational identity and had a huge impact on entire humanity, including development of science, philosophy, theology, literature, and art;
- **3.** Gathered together at a time of profound changes, which are taking place in Asia, Eurasia, Europe and the entire world, to set up a joint vision for building

our brighter future, based on common history, language, culture, traditions, and values of the Turkic peoples;

- **4.** Reaffirming our commitment to the following as the basis for our future cooperation:
- the UN Charter; the Nakhchivan Agreement on the Establishment of the Cooperation Council of Turkic Speaking States (CCTS/Turkic Council); ten declarations of the CCTS/OTS Council of Heads of State: the Almaty Declaration of the First Summit; the Bishkek Declaration of the Second Summit; the Qabala Declaration of the Third Summit; the Bodrum Declaration of the Fourth Summit; the Astana Declaration of the Fifth Summit; the Cholpon Ata Declaration of the Sixth Summit; the Baku Declaration of the Seventh Summit; the Baku Declaration of the First Extraordinary Summit, the Turkistan Declaration of the First Informal Online Summit; the Istanbul Declaration of the Eighth Summit; the Samarkand Declaration of the Ninth Summit and the Ankara Declaration of the Second Extraordinary Summit,;
- the Istanbul Declaration of the Eighth OTS Summit, on which we decided to change the name of the "Cooperation Council of Turkic Speaking States" to the "Organization of Turkic States" and adopted the strategic document "Turkic World Vision 2040"; the Samarkand Declaration of the Ninth OTS Summit, on which we signed the Protocol on amendments to the Nakhchivan Agreement on the Establishment of the Turkic Council, adopted the new OTS Rules of Procedure, and endorsed the OTS Strategy for 2022-2026" for the implementation of the "Turkic World Vision 2040",
- **5.** Being confident that full, equal and comprehensive implementation and observance of the principles, provisions and commitments enshrined in the Nakhchivan Agreement will create the conditions for advanced cooperation among the OTS Member States, and will guide us towards a better future, which our brotherly peoples so much deserve;
- **6.** Recognizing the interlinkages, interdependency and interrelationship between peace, security, stability, sustainable development and humanitarian domain in our part of the globe and in the rest of the world; and considering that more collaboration and confidence-building measures should be pursued by the OTS actively in all related aspects, including political-military, economic environmental, as well as humanitarian-cultural dimensions;
- **7.** Committing therefore ourselves to working closely to enhance multilateral framework for ensuring peace, security, stability, sustainable development and humanitarian progress, as well as exploring new opportunities for further deepening and widening our interaction and solidarity, while making the OTS effective platform to enhance our capabilities for dialogue and co-operation on issues of common concern for our fraternal peoples;
- **8.** Expressing satisfaction with the achievements made by the OTS since its establishment and the remarkable political and socio-economic progress that

the Turkic States achieved since their independence, as well as declaring our determination to transform Turkic world into a common and indivisible area of advanced integration, security, sustainable development and humanitarian harmony, where all states peacefully co-exist, and their peoples live in conditions of peace, freedom and prosperity, and confident that peace, security, development and humanitarian dimension complement, sustain and reinforce each other;

- **9.** Being resolved to enhance the Organization's role in ensuring cooperative, collaborative and coordinated action in its area of responsibility and further promoting our joint values and interests in the regional and international arena; as well as to hold wider OTS consultations on regional and international issues affecting the interests of the Turkic World to elaborate and develop a consolidated position among the Member States.
- **10.** Aiming at strengthening security and stability of the Member States in accordance with the generally recognized norms and principles of international law, in particular those related to the respect of and support for the sovereignty, territorial integrity and inviolability of the internationally recognized borders, noninterference in internal affairs;
- **II.** Underscoring the utmost importance of continuing joint efforts by all Member and Observer States aimed at promoting development agenda, SDGs and Agenda 2030 in economic dimension, inter alia, through promoting trade, transport, investment, and regional connectivity related initiatives.

HAVE ADOPTED THE FOLLOWING PRIORITIES TO BE OPERATIONALIZED AS OUR JOINT ACTION:

I. Social and cultural dimension priority (Traditions)

Guided by the understanding of the fact that the OTS was established on the basis of a unifying principle in the form of a common tradition, language, culture, the importance and indivisibility of historical roots will be given to:

- augmenting the spiritual connection between the Turkic peoples, studying and mainstreaming the common heritage, history and modern achievements of the Turkic peoples;
- joint study of the common written heritage, the history of the Turkic peoples using national and international archives, including elimination of "blank spots" and distortions of historical facts,
- protection and promotion of the cultural code of the Turkic nations as a social and civilizational pillar for future development;
- organization of the 5th World Nomad Games in September 2024 in Kazakhstan as an important initiative to promote the common heritage of the Turkic peoples;
- carrying out the relevant works for inscribing multinational elements on the

UNESCO lists";

- continuation of the tradition of holding Meetings of National Commissions for UNESCO of TURKSOY member states in the cities declared the "cultural capital of the Turkic World"
- enhancement of youth-to-youth cooperation in order to engage young people in discussions on regional and global issues and encourage their active participation in the development of the Turkic world;
- ensuring that all efforts and initiatives within the OTS prioritize gender equality and the empowerment of women, which can be integrated across all dimensions of cooperation, as it is essential for the development and progress of the Turkic world.

II. Harmonization and standardization priority (Unification)

Unification is of lasting importance for the unity and development of the Turkic world. In this regard, it will be important to support and consistently promote:

- exploring the possibilities of approximation of the laws of the Turkic countries where possible and in so far as it is related to the cooperation foreseen under the Nakhchivan Agreement, without prejudice to national legislations of the member states and international agreements to which they are parties. It is important to explore possibilities for the development of model laws, the implementation of which will aim at contributing to the formation of a single space. Model laws would remove the restrictions that hinder the further integration of our countries;
- activities of the Common Alphabet Commission under the Turkic Academy aimed at creating a common Turkic alphabet could contribute to form a common text space, understandable in terms of reading and pronunciation by all Turkic peoples, that will gradually contribute to the convergence of the peoples in the Turkic world;
- harmonization of diverse ties between the Turkic states in the political, economic, humanitarian and other fields through enhanced diplomatic coordination;
- unification of technical regulations, standards, accreditation terms, procedures of compliance assessment, models, terminology without prejudice to the international obligations of the Member States to ensure the efficiency of economic, financial, industrial, and other processes and industries; increasing the competitiveness of goods, services, works ensuring the safety of the population and the environment; saving material, energy, labor resources, simplifying control;
- harmonization of tariff policy in transportation in order to speed up transport operations and optimize logistics costs;

- harmonization of the flags and emblems of the Turkic Cooperation Organizations (TCOs), namely OTS, TurkPA, Turksoy, Turkic Academy, Turkic Culture and Heritage Foundation, Turkic Investment Fund.

III. Further optimal institutionalization priority (Reforms)

In order to increase the efficiency of the OTS, to eliminate duplication of functions within the framework of Turkic cooperation organizations and to improve project activities, it is necessary to:

- carry out consistent work to revive and improve the quality of work of the OTS Coordination Committee;
- optimize the work of Turkic cooperation organizations and rationalization of the project activities of the OTS;
- consolidate the efforts of the OTS through result oriented and concrete projects based on common objectives and principles of efficient use of resources within certain timelines, frugal spending and effective financial management.

IV. Scientific and educational priority (Knowledge)

- In order to strengthen the synergy of the educational and scientific potential of the Turkic countries, as well as to unite the Turkic youth, it seems important:
- to encourage OTS staff/diplomats to participate in the training programs offered by the member states in order to contribute to the capacity-building of the Organization;
- opening branches of universities, language departments, to carry out a more intensive student and scientific exchange, as well as holding of joint conferences and other events;
- to facilitate the development and improvement of cooperation and coordination among Turkic universities;
- strengthening cooperation between the analytical centers of the OTS states. Joint "brainstorming" of the leading experts of our countries will be aimed at solving issues related to modern challenges and threats;
- development of science-intensive industries, including artificial intelligence, digital and aerospace;
- skills development, focusing on the provision of high-quality knowledge and capacity building for youth and women to ensure their competitiveness;
- further strengthening cooperation in media sector.

V. Security (military-political) cooperation priority (Trust)

In the light of increased security threats and challenges including terrorism and cybercrimes, which create conducive environment for illicit trade of weapons and drugs as well as human smuggling, closer cooperation is needed under the following issues:

- preventing and countering terrorism and violent extremism in all its forms and manifestations, including exchange of information and experience for implementing effective prosecution and rehabilitation strategies, without prejudice to national laws and international agreements to which member states are parties;
- cooperation against Islamophobia;
- cooperation through the law enforcement and competent security authorities of the Turkic states;
- development of joint approaches and appropriate preventive measures to ensure cybersecurity and economic security in the region;
- strengthening cooperation and mutual assistance in the field of emergency response;
- strengthening cooperation between relevant institutions and defense enterprises to exchange experience in the field of military innovation, as well as defense and aviation technology, and to consider developing joint projects and establishing joint production;
- promoting the nuclear-weapon-free zones status of the Central Asia;
- jointly elaborating and supporting relevant and appropriate initiatives towards world free of conflicts, weapons of mass destruction, and terrorism;
- enhancing security and military cooperation among the Member States to address common security threats; promoting cooperation in military science and education among OTS Member States;
- continuing consultations among OTS Member States on initiatives to strengthen the implementation of relevant international instruments in the field of arms control, disarmament and non-proliferation, including as appropriate, on possible options for strengthening the Biological Weapons Convention";
- strengthening the contribution of OTS to regional peace and security.

VI. Economic and financial dimension priority (Investments)

Close attention to the state and development of trade and economic ties, transport and logistics, connectivity, solving issues of food security, mutual investment, expanding cooperation in the field of modern digital and green/

clean energy technologies in accordance with national legislations of the Member States in the OTS space becomes vital. In this context, particular importance will be given to:

- the formation of a unified digital transport system with the OTS member states along the Trans-Caspian International East-West Middle Corridor, and development of other similar infrastructure projects which enhance connectivity and contribute to economic growth;
- promotion of the Trans-Caspian International East-West Middle Corridor through establishing a unified digital transport system, creating favorable conditions and prioritizing carriers from Turkic countries as well as developing infrastructure projects which boost connectivity and contribute to economic growth, including railway routes the "Baku-Tbilisi-Kars", "China-Kyrgyzstan-Uzbekistan" and "Kazakhstan- Turkmenistan Iran" and "Termez-Mazar-i-Sharif-Kabul-Peshawar" as well as the transport communications connecting the East Zangezur Economic region and Nakhchivan Autonomous Republic of the Republic of Azerbaijan;
- enhance coordination to shape common positions within regional cooperation organizations to promote the transport routes passing through the territories of their states within multilateral fora where competing transport corridors exist;
- development of cooperation in the field of tourism, increasing the sustainability of the tourism sector through the diversification of tourist destinations, introduction of new flight routes to improve connectivity, improving the quality of tourism services while minimizing the negative impact of tourism on the environment;
- assistance to the economic and financial and investment development of the OTS member states by expanding intra-regional trade; supporting economic activity; promotion of mutual investments;
- development of industrial cooperation via launching joint projects and programs in mutually beneficial and priority areas;
- development of the green capital market, green technologies, coordination of actions for decarbonization;
- development of start-up projects of the OTS countries and popularization of IT and the venture sector among entrepreneurs;
- introduction of modern agricultural technologies, strengthening of the scientific and innovative potential of the member states, development of cooperation in the field of agriculture to ensure food security;
- strengthening cooperation in the field of climate change and protection of the environment.

VII. Peace priority (Mediation)

The role of Turkic states in mediating international disputes both intra-state and inter-state conflicts is growing. Member states have worked actively towards the resolution of many conflicts in a broad geography and gained international experience in peacemaking and mediation, inter alia, through taking an active role in multilateral institutions.

As responsible members of the international community and supporter of peace in order to qualitatively develop peacemaking and mediation capacity, the OTS countries shall:

- ensure synergy, capacity building, share experiences, lessons learned and best practices for mediation between inter-governmental (G2G), interacademia (A2A) and interpersonal relations (P2P) in all areas of activity of Turkic structures, while expanding contacts, connections and joint projects;
- encourage OTS member states' participation to efforts of the relevant international organizations to which they are members in the field of mediation and jointly work towards increasing their effectiveness;
- promote efforts and creative processes, aimed at solving global and regional problems in a constructive manner and further increase cooperation and synergy between OTS countries towards finding peaceful resolutions to conflicts;
- combine efforts to transform Conference on Interaction and Confidence Building Measures in Asia (CICA) into a full-fledged international organization as a one of the important platforms to voice and implement joint mediation initiatives of Turkic States in our part of the world and beyond;

VIII. Promotion of power sector and energy-environment priority (Energy)

For OTS countries, as important electric energy, clean/green energy, hydrocarbons, and uranium producers/exporters, the development of power sector, clean energy /green technologies and environment is essential. In this context, particular importance will be given to:

- intensification of cooperation on energy issues, inter alia, in the field of traditional fuels and renewable energy sources, diversification of energy routes, supplies, and promotion of joint energy projects;
- promoting joint efforts to address environmental challenges, such as climate change, desertification, deforestation, land degradation and sustainable use of water resources;
- coordination of actions for decarbonization, development of green energy transition and establishment of green energy zones;
- development of cooperation with the International Atomic Energy Agency (IAEA); including the pending issue of restoration of sovereign equality in

- IAEA intensification of cooperation on energy issues in the field of traditional fuels and renewable energy sources, diversification of energy routes;
- enhancing cooperation with the respective international and regional organizations, fora, centers, institutes, and laboratories on energy matters;

Harmonization of Flags of the Turkic Cooperation Organizations

At the Astana Summit, held with the theme "TurkTime," leaders of Member States emphasized their commitment to strengthening cooperation within the Turkic World and fostering unity among Turkic States through the Organization of Turkic States framework.

Among the pivotal resolutions included in the Astana Act, an important decision emerged — the harmonization of flags and emblems across key institutions within the Turkic world. This encompassed entities such as OTS, TurkPA, TURKSOY, Turkic Academy, Turkic Culture and Heritage Foundation, and the Turkic Investment Fund.

On November 3, 2023, following the provisions outlined in Articles 4 and 5 of the Nakhchivan Agreement on the Establishment of the Cooperation Council of Turkic Speaking Countries, the Council of Heads of States decided to align the flags of Turkic Cooperation Organizations. This alignment followed the flag of the Organization of Turkic States, approved by the Council of Foreign Ministers on August 22, 2012, in Bishkek.

The decision to harmonize the flags of Turkic Cooperation Organizations is another demonstration of the commitment of Member States to present common depiction of united collective goals and unified objectives.





❖ TURKPA

Parliamentary Assembly of Turkic States was established on 21 November 2008 by the Istanbul Agreement signed by the Heads of Parliaments of the Republic of Azerbaijan, Republic of Kazakhstan, Kyrgyz Republic, and the Republic of Türkiye in Istanbul in order to develop and strengthen inter-parliamentary cooperation among the Member States.

TURKSOY

The International Organization of Turkic Culture, TURKSOY, is the UNESCO of the Turkic World and was established in 1993 upon signing of its founding agreement by the Ministers of Culture of Republic of Azerbaijan, Republic of Kazakhstan, Kyrgyz Republic, Republic of Uzbekistan, Turkmenistan and Republic of Türkiye.

***** TURKIC ACADEMY

Turkic Academy was founded in 2012 by Republic of Azerbaijan, Republic of Kazakhstan, Kyrgyz Republic and Republic of Türkiye as an international organization under the aegis of the Organization of Turkic States (then called Turkic Council) with the aim of coordinating scientific researches on the language, literature, culture, history of Turkic people and evaluating the contribution of the Turkic civilization to the human civilization based on indigenous sources.

❖ TURKIC CULTURE AND HERITAGE FOUNDATION

The Turkic Culture and Heritage Foundation started its activities following the decision of Heads of States during the Astana Summit, which was held on 11 September 2015. The Charter of the Foundation was adopted at the Bishkek Summit on 23 August 2012. The Foundation's Secretariat is located in Baku, Azerbaijan.

❖ TURKIC INVESTMENT FUND

Turkic Investment Fund is the first joint financial organization of the Turkic states, aiming to empower trade and economy and initiate new developmental and entrepreneurial projects. The deal initiated during an extraordinary summit of Organisation of Turkic States on March 16 2023 to set up Turkic Investment Fund was finalised in 2024 among Republic of Azerbaijan, Republic of Kazakhstan, Kyrgyz Republic, Republic of Türkiye and Republic of Uzbekistan.

❖ UNION OF TURKIC CHAMBERS AND COMMERCE AND INDUSTRY (TCCI)

The Union of Turkic Chamber of Commerce and Industry (TCCI) established in 2022 with a permanent Secretariat in Istanbul, with a view to support and foster cooperation among the business circles of the Turkic States and thus further achieve economic integration and economic and social development therein.

János Hóvári

János Hóvári was the head of the Representation Office of the OTS in Budapest, professor of the Institute of History of the Károli Gáspár University of the Reformed Church in Hungary. He graduated from the departments of History and Turcology at Eötvös Lorand University, Budapest (1979). Between 1979 and 1992, he was a research fellow at the Institute of History of the Hungarian Academy of Sciences and an assistant professor at Janus Pannonius University, Pécs. He obtained his PhD (1997) in Ottoman Studies. He joined Hungary's Ministry of Foreign Affairs in 1992 and served as Hungary's ambassador to Israel (2000–2004), Kuwait and Bahrain (2008–2010), and Türkiye (2012–2014), and as a Deputy State Secretary on Global Issues (2010–2012). He is the author of several books and a number of academic and cultural publications. His main research fields are the Ottoman Empire in the sixteenth century, Hungarian–Ottoman relations, Hungarian–Turkish relations, and Balkan and Central Asian Studies.

Rooted in the shared foundations of common history, language, culture and traditions, the OTS aims to foster enhanced collaboration among its member states and observers. This collaboration spans a wide spectrum of sectors, encompassing economy, politics, science, education, transportation, energy, customs, tourism, diaspora, health, youth and sports and more.

» Organizational Structure



The main bodies of the Organization of Turkic States (OTS) are; the Council of Heads of State, Council of Foreign Ministers, Senior Officials Committee, Council of Elders and the Secretariat. Annual summits under specific topics allow Heads of State to evaluate the achievements and set goals for the upcoming year.

The OTS Secretariat, headquartered in Istanbul, oversees operations, while a Representation Office in Budapest, Hungary, promotes interaction and cooperation with European institutions and prominent international organizations based in Europe. 
to both regional and global peace and stability. Member states express unwavering commitment to fundamental principles, including democracy, human rights, the rule of law, and good governance.


Built on a foundation of shared values and unity, the OTS endeavors to shape a harmonious geopolitical, geo-economic, and cultural landscape, while safeguarding
